The proviso to Section 68(2)(c) of the Companies Act, 2013, as amended, and Regulation 4(i) of the Securities and Exchange Board of India (Buy-Back of Securities) Regulations, 2018 state that the buyback of equity shares in any financial year shall not exceed 25% of the total paid up equity capital of the company in that financial year. The indicative maximum number of Equity Shares to be bought back at the Maximum Buyback Size and the Maximum Buyback Price is 2,24,736 Equity Shares, which does not exceed 25% of the total paid up equity share capital of the Company (i.e. 24,75,820 Equity Shares). If the Equity Shares are bought back at a price below the Maximum Buyback Price, the actual number of Equity Shares bought back could exceed the indicative Maximum Buyback Shares (assuming full deployment of Maximum Buyback Size) but will always be subject to Maximum Buyback Size.

As the Equity Shares are bought back at a price below the Maximum Buyback Price (i.e. Rs. 3,800), the actual number of Equity Shares bought back exceed the indicative Maximum Buyback Shares (i.e. 2,24,736 Equity Shares) but will always be subject to Maximum Buyback Size (i.e. Rs. 8,540 lakhs) and does not exceed 25% of the total paid up equity share capital of the Company (i.e. 24,75,820 Equity Shares).

The Company has appointed Edelweiss Securities Limited as their broker for the Buyback.

The above information is subject to settlement as per the existing rules for secondary market transactions of the Stock Exchanges and verification of Equity Shares bought back, where applicable.
