# Bhagyanagar Chlorides Private Limited- ISSUER NOT COOPERATING due to Non-Submission of No Default Statement (NDS)

# Rationale

ICRA has moved the rating of **Bhagyanagar Chlorides Private Limited (BCPL)** to the 'ISSUER NOT COOPERATING' category due to non-submission of monthly 'No Default Statement' ("NDS") by the entity.

ICRA has been consistently following up with **BCPL** for obtaining the monthly 'No Default Statement'. However, the entity's management has remained non-cooperative and ICRA has not received NDS for two consecutive months of November 2022 and December 2022.

ICRA is unable to validate whether **BCPL** has been able to meet its debt servicing obligations in a timely manner. Accordingly, the lenders, investors and other market participants are advised to exercise appropriate caution while using this rating.
