ICRA has retained the Issuer Rating of Siddipet Municipality in the 'Issuer Not Cooperating' category. The rating is denoted as "[ICRA]B+(Stable); ISSUER NOT COOPERATING".

ICRA has been trying to seek information from the entity so as to monitor its performance. Further, ICRA has been sending repeated reminders to the entity for payment of surveillance fee that became due but despite repeated requests by ICRA, the entity's management has remained non-cooperative. The current rating action has been taken by ICRA basis best available/dated/ limited information on the issuers' performance. area of 50.03 sq. km. and serves a population of 1.45 lakh (Projected as on date). Its main functions include water supply, solid waste management, sewerage and construction, repair and maintenance of roads and street lights in its area. The ULB is divided into 34 municipal wards and is governed by an elected body (Council) headed by a Chairperson, while the Commissioner acts as the chief executive overseeing its everyday functioning.
