NeoGrowth Credit Private Limited: Rating confirmed as final for Series A1 SN backed by MSME business loan receivables issued by Aryabhata-1 Trust July 2023

Summary of rating action

Rationale

In July 2023, ICRA had assigned a Provisional [ICRA]A+(SO) rating to Series A1 SNs issued by Aryabhata-1 Trust July 2023 under a securitisation transaction originated by NeoGrowth Credit Private Limited {NCPL; rated [ICRA]BBB (Stable)}. The SNs are backed by a pool of Rs. 35.81-crore (pool principal; receivables outstanding of Rs. 29.86 crore) micro, small and medium enterprise (MSME) business loan receivables originated by NCPL. Since the executed transaction documents are in line with the rating conditions and the legal opinion for the transaction has been provided to ICRA, the said rating has now been confirmed as final.

A summary of the performance of the pool after the October 2023 payout month is provided below.

Key rating drivers

Credit strengths

- Availability of credit enhancement in the form of EIS, subordination and CC
- Absence of overdue contracts as on pool cut-off date

Credit challenges

- High geographical concentration in the pool with top 3 states accounting for ~71% of the pool principal.
- Exposed to inherent credit risk associated with the unsecured nature of the asset class; performance of the pool would remain exposed to macro-economic shocks / business disruptions, if any.

Description of key rating drivers highlighted above

According to the transaction structure, the loan pool receivables have been assigned at par to the SN investors. The promised cash flow schedule for Series A1 SN, on a monthly basis, will comprise the interest at the predetermined yield on the outstanding SN principal on each payout date and the entire principal on the final maturity date. The first line of support for Series A1 SN in the transaction is in the form of a subordination of 15.00% of the pool principal (equity tranche of 5.00% of the pool principal and over-collateralisation of 10.00% of the pool principal). Additionally, the EIS (12.73% of the pool principal initially, based on the indicated SN yield, for Series A1 SN) available in the structure will provide CE support to the transaction. The surplus EIS available, after meeting the promised payouts to the SNs, shall flow back to the originator on every payout. All prepayment amounts would be passed on to Series A1 SN (till Series A1 SN principal is not fully amortised) every month and future payouts will be revised accordingly. The CC of 5.00% of the initial pool principal (Rs. 1.49 crore), provided by NCPL, would act as further CE in the transaction. In the event of a shortfall in meeting the promised SN payouts during any month, the Trustee will utilise the CC to meet the same.

There are no overdues in the pool as on the cut-off date. The geographical concentration of the loan contracts in the current pool is high with the top 3 states constituting ~71 of the pool principal. The pool consists of monthly paying loan contracts, with moderate weighted average seasoning (7.35 months) and pre-securitisation amortisation (21.71%). Further, the CIBIL score of almost all the contracts is above 700. The pool's performance is expected to remain exposed to the underlying credit risks inherent in the asset class and macro-economic shocks/business disruptions.

Past rated pools performance: ICRA has rated 12 PTC transactions of NCPL, of which three have matured. The performance of the live pools (which have completed at least 2 months post securitisation) has been healthy with monthly collection efficiency of more than 95% and no CC utilisation till the October 2023 payout.

Key rating assumptions

ICRA's cash flow modelling for rating asset-backed securitisation (ABS) transactions involves the simulation of potential delinquencies, losses (shortfall in principal collection during the tenor of the pool) and prepayments in the pool. The assumptions for the loss and coefficient of variation (CoV) are arrived at after considering the performance of the originator's portfolio as well as the characteristics of the specific pool being evaluated. Additionally, the assumptions may be adjusted to factor in the current operating environment and any industry-specific factors that ICRA believes could impact the performance of the underlying pool of contracts.

After making these adjustments, the expected mean shortfall in principal collection during the tenure of the pool is estimated at 5.50-6.50% of the initial pool principal, with certain variability around it. The prepayment rate for the underlying pool is estimated in the range of 12.0-18.0% per annum.

Liquidity position: Strong

As per the transaction structure, only the interest amount is promised to the SN holders of Series A1 on a monthly basis while the entire principal amount is promised on the scheduled maturity date of the transaction. The cash flows from the pool and the available CE are expected to be comfortable to meet the promised payouts to the Series A1 SN investors.

Rating sensitivities

Positive factors – The rating could be upgraded on the sustained strong collection performance of the underlying pool of contracts (>95%), leading to lower-than-expected delinquency levels, and on an increase in the cover available for future investor payouts from the credit enhancement.

Negative factors – The rating could be downgraded on the sustained weak collection performance of the underlying pool (monthly collection efficiency <90%), leading to higher-than-expected delinquency levels and credit enhancement utilisation levels.

Analytical approach

The rating action is based on the analysis of the performance of NCPL’s portfolio till June 2023, the key characteristics and composition of the current pool, the performance expected over the balance tenure of the pool, and the CE cover available in the transaction.

NeoGrowth Credit Private Limited (NCPL) is a non-deposit taking systemically important non-banking financial company, which started operations in FY2013. It was founded by Mr. Dhruv Khaitan and Mr. Piyush Khaitan, and its investors include Omidyar Network, Aspada Investment Advisors, Khosla Impact Fund, Frontier Investments Group (Accion), FMO, Plenitude Ventures Private Limited and IIFL Seed Ventures Fund. Before setting up NCPL, the founders had established and managed Venture Infotek, which provided end-to-end card payment processing solutions to banks that issue credit cards and those with whom merchants have a point-of-sales terminals. The founders divested their stake in the company in 2010.

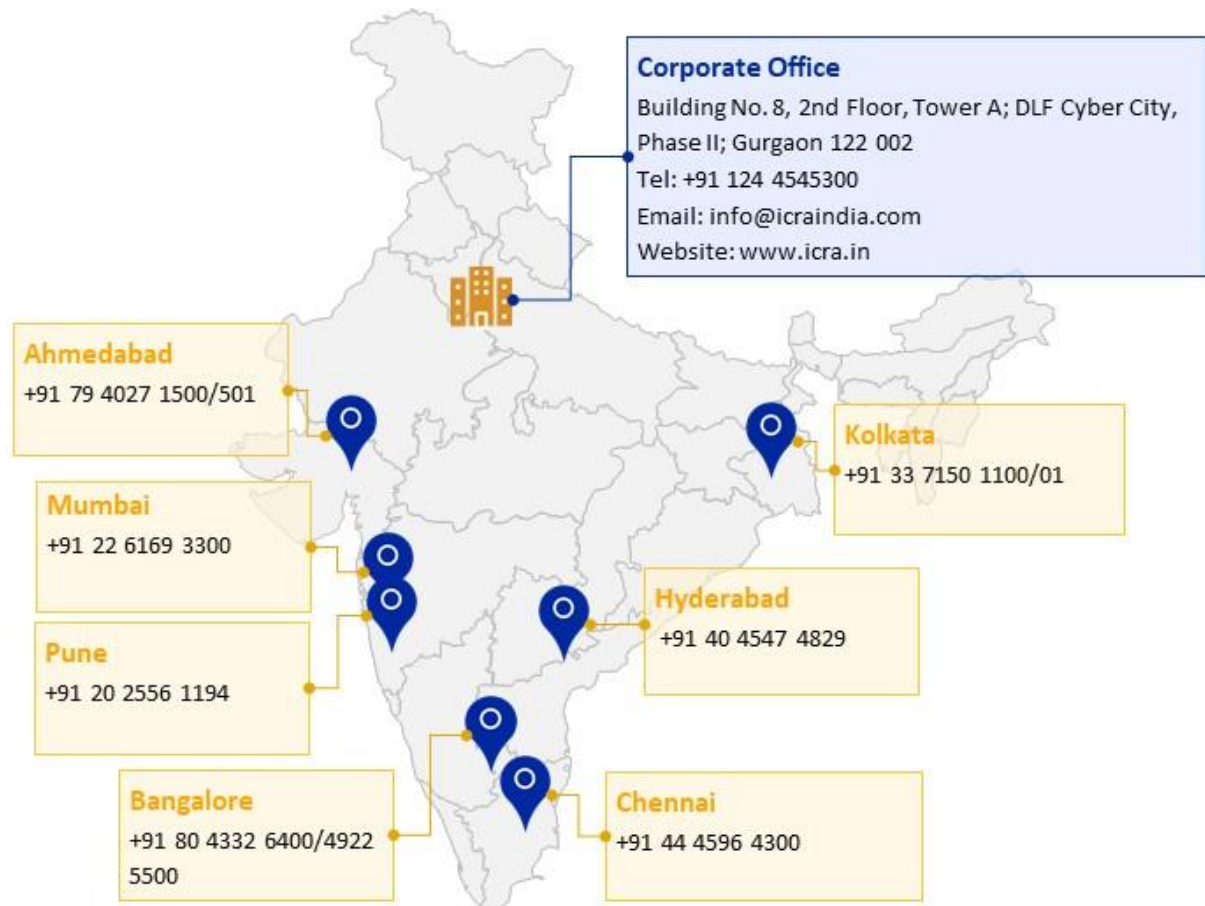
